The Nigeria Labour Congress (NLC) has chided the Governor of Ogun State, Ibikunle Amosun, over a statement credited to him in which he threatened to disgrace its leadership for insisting to embark on a protest on Tuesday in the state.

NLC President Ayuba Wabba in a statement, Friday, said the governor's threats will not deter it from defending the interest of workers in Ogun State whose rights, he claimed, the governor has been trampling upon.

Wabba accused the governor of non-

remittance of statutory deductions from workers' salaries for pensions, cooperative, 'Ileya', Christmas etc. over a period of 105 months.

He also accused the governor of nonutilization of the last tranche of the Paris Club refund for the payment of gratuity for both state and local government workers since 2013, despite signing a collective agreement with organized labour in the

Wabba further accused the governor of refusing to pay workers at the Tai Solarin College of Education their salary arrears that accumulated for the past 10 years and now grossed to a financial liability of about N9 billion, alleging that the governor sacked the chairman of the NLC from his employment for standing firm in the defense of the rights of workers in the

The issues we have highlighted are too grievous to be swept under the carpet, therefore, the decision of the 12th National Delegates Conference of the NLC to confront and engage Governor Amosun will be carried out to the letter on Tuesday.

"Our confidence stems from the protection and guarantees provided by Section 40 of the 1999 Nigerian Constitution which gives workers and indeed all Nigerians the freedom to

"All that the law requires us to do is to inform the police and relevant security agencies. This we have done. We are agencies. This we have done, we are ready to peacefully protest the grievous mistreatment by our workers in the hands of Governor Ibikunle Amosun on 5th March 2019," Wabba said. He said it was unfortunate that a

He said it was unfortunate that a sitting governor and a former senator like Amosun could descend into violent utterances in order to cow workers, adding that he would be held personally responsible for any harm that comes to any worker during its protest scheduled for Tuesday.

ILO harps on decent jobs

The International Labour Organisation (ILO) has urged government and other employers of labour across the world to strive to provide not just jobs but decent jobs in order to place human society on the path of progress.

Damian Grimshaw, the International Labour Organisation (ILO) Director of

Research made this call in a report.

He noted that over 700 million people are living in extreme or moderate poverty. despite having employment, attributing it to high level of poor working conditions millions of workers across the world faced.

faced.
According to Grimshaw, a report of the International Labour Organization's World Employment and Social Outlook (WESO): Trends 2019 report, stated that despite the minimal 4.5 per cent of the working age population are unemployed in Africa while 60 per cent unemployed in Africa while 60 per cent are employed, the number of people living under poverty line in the continent is enormous.

"Poor quality employment is the main issue for global labour markets, with millions of people forced to accept inadequate working conditions,

accept inadequate working conditions, especially in Africa.

"WESO: Trend 2019 shows that a majority of the 3.3 billion people employed globally in 2018 had inadequate economic security, material well-being and equality of opportunity.

"Progress in reducing unemployment globally is not being matched by improvements in the quality of work," ILO said, quoting WESO Trends 2019

Following this new revelation, ILO decried the persistent number of major deficits in decent work, and warned deficits in decent work, and warter that, "with the current rate of progress attaining the goal of decentwork for all, as set out in the Sustainable Development Goals (SDGs), particularly SDG 8, seems

Goals (SDGs), particularly SDG 8, seems unrealistic for many countries."

Commenting on the alarming declining rate of decent jobs, Deborah Greenfield, ILO Deputy Director-General for Policy Issue said, "SDG 8 is not just about full employment but the quality of that employment. Equality and decent work are two of the pillars underpinning sustainable development.

work are two of the pillars underpinning sustainable development.

Grimshaw said, "Being in employment does not always guarantee a decent living. For instance, a full 700 million people are living in extreme or moderate poverty despite having employment."

Among the issues highlighted is the lack of progress in closing the gender gap in labour force participation.

lack of progress in closing the gender gap in labour force participation.

The ILO also said, "Only 48 per cent of women are in the labour force, compared to 75 per cent of men. Women also make up far more of the potential, underutilized, labour force. Another issue is the persistence of informal employment, with a staggering 2 billion workers — 61 per cent of the world's workforce — categorized as such. Also of concern is that more than one in five young neople (under 25) are not five young people (under 25) are not in employment, education or training, compromising their future employment prospects," the report stated.

Nigerian Maritime Administration and Safety Agency (NIMASA) has mised the nlarm that Nigerian importers are paying highest freight rate on import in the world due to dangers attached to Nigerian territorial waters.

According to the director-general of NIMASA, Dr. Dakuku Peterside, this was as a result of false reportage about attacks on the nation's territorial water. Peterside disclosed this when members of the Shipping Correspondents Association of Nigeria (SCAN) paid a courtesy visit to the agency over the weekend.

Peterside lamented that Nigeria is slammed war risk surcharge over lumpsom data on maritime crime in the country. The NIMA-SA director-general, who was represented by the executive director, Finance and administration, Bashir Yusuf Jamoh, said while attacks in Gulf of Guinea (GoG) are erroneously considered as attacks on Nigeria territorial waters, sea robberies are mistakenly referred to pirate attacks thereby giving Nigeria false communities.

"Someone read out a statistical report that about 88 Piracy attacks are being re-ported but there are misconception because I just fin-ished my PhD and my area of specialisation is maritime security and what I discovered in the course of my research is that number without time, we lumpsom data on issues of maritime crime. Nigeria and gulf of Guinea.

Peterside also urged journalists to correctly educate and inform the public about attacks saying crime that occurred in Benin republie shouldn't be referred to crime that occur on Nigeria waters, "It's your duty as reporters to ensure you report

"A situation where a crime happened in Benin Republic or Togo or any part of Ghana, Cameroon and we lump in on Nigeria because we are part of gulf of Guinea as Nigeria, we will continue to send a very wrong signal to the inter national communities and as a nation, people will be scared to be around.

"Already, we are paying war premium in terms of insurance and we stand to be

the highest payee of freight all over the world because of the dangers attached to our own territorial waters he said. Comparing freight rate from America to Ghana, Peterside said Nigeria paid highest freight rate de-

spite same distance.

According him, the cost of probably freight from America to Gliana which is almost the same distance to Nigeria with that of US to Nigeria, you will find out that Nigeria pay more than Nigeria and at the end, all of us here pay the premium because it ends on the consumer and when we consumes definitely anything we pay In excess will be distributed among the con-

ABCON Sets N250/\$ Exchange Rate Agenda For PMB

The Association of Bureaux de Change Operators of Ni-geria (ABCON) has set N250 to dollar exchange rate agenda for President Muhammadu Buhari in his second term in office.

ABCON President, Alhaji (Dr) Aminu Gwadabe, who disclosed this to financial journalists in Lagos, said achieving a lower exchange rate for the econo-my will benefit the common man and lift businesses. The naira exchanges at N362 to dollar at the parallel mar-ket and N358 to dollar at the Bureaux De Change (BDC) while the local currency exchanges at N306 to dollar at the official rate.

The ABCON boss also said such lower exchange

rate will improve the transac-tion volume for BDCs by enabling operators to buy and sell more dollars from their available cashflow.

He said a lower exchange rate against the greenback will stabilize the local currency, raise investors' confidence, improve Diaspora re-mittance flow and entrench

mittance flow and entreach fiscal discipline. Continuing, he said a stronger Naira will raise In-ternally Generated Reve-nue, help in the implemen-tation of the restriction of foreign exchange access to 42 items that can produced locally and improve BDCs capabilities to thrive.

Gwadabe therefore ad-vised the Federal Government to constitute new economic management team and review government's performance in the last four years. He added that such review will give room for better performance in the second term of this administration which commences in May 29, 2019.

Gwadabe said the economy is not performing to ex-pectations, and government is expected to re-strategise and review its performance in the last four years and develop concrete actionable strategy for better perfor-mance. The All Progressive Congress (APC) candidate, Muhammadu Buhari, emerged the winner of the 2019 presidential election in Nigeria. The incumbent president, who defeated 73 other candidates, scored a total of 15,191,347 votes across 19 states

Gwadabe said that if gov-

emment waits till May 29 before setting up a think-tank economic team with functional experience on the economy, security, agricul-ture and human resource development, it would have wasted tangible time needed for smooth take-off.

He said the committee members should have deep knowledge of the economy, and be ready to access information on how these sectors have worked effectively in other countries in order to deploy similar strategy in the interest of the local economy.

Gwadahe said that by now, government should know where the complaints over its performance in the last four years came from and give priority to tackling unemployment, fixing road infrastructure, creating bet-ter investment opportunities for the people and companies as well as strengthening the financial sector, of which BDCs are key play-ers. The ABCON boss said: "It is only when the economy is buoyant, that they peo-ple will be able to save, and that provide enough liquidity for banks to lend and fuel the economy. The other subsectors including the bureaux de change sector will equal-ly be positively impacted y a thriving economy

Gwadabe also advised the Federal Government to be more cautious at borrowing, ensuring that borrowed funds are channeled to projects that will be able to repay the loans. He said gov-ernment should equally look at the tax system, and block all revenue leakages to gen-erate more funding for the economy.
